

## Purchase Order Quality Notes

<b>The Following Clauses Apply to all Purchase Orders</b>	
1	<b>Right of Entry</b> The buyer and buyers' customer, and their customers, or any applicable regulatory agency will have the right to enter the supplier's facility to perform inspection or ensure compliance to the contract.
2	<b>Acceptance</b> of this order, or the initiating of any process, or the furnishing of any product, or the acceptance of payment, constitutes unconditional acceptance of all requirements as stated within this document and the purchase order by the supplier.
3	<b>Amendments</b> to this order or terms and conditions shall be outlined in writing, via purchase order change notice, and revisions to the purchase order terms and conditions. Fuji Industries Corp. will consider supplier's request to modification of, or exception to, only if such request is made in writing, before the acceptance of the order.
4	<b>Packaging and Protection</b> of the product shipped shall be by the PO or best commercial practice to protect product from damage and deterioration.
5	<b>Change Notification</b> where appropriate, the supplier shall notify Fuji Industries Corp. of changes in product and process definition where fit, form or function may be affected. <b>Cancellation</b> shall remain the right of the buyer and may be initiated at any time.
6	<b>Non-conformances</b> It is the responsibility of the supplier to inform Fuji Industries Corp. when it has been determined that a nonconforming product has been shipped to Fuji Industries Corp. or its customers and obtain organization approval for nonconforming product disposition.
7	<b>Record Retention</b> Supplier shall retain all records about material/manufacturing process special processes, test, and inspection for a minimum of 10 Years or as required by the Fuji Industries Corp. customer; Changes to this requirement shall be addressed on the purchase order. Notify Fuji Industries Corp. before destruction. Additional Fuji Industries Corp. quality requirements apply when referenced by Fuji Industries Corp.
8	<b>Flow down to Sub tiers</b> - Suppliers is required to flow down to their suppliers and sub-tier supplier any requirements that are presented by Fuji Industries Corp.
9	<b>Suppliers performance</b> is monitored based on Quality and Delivery - Goals have been established at 90%; Suppliers shall be informed if the supplier does not meet the goal for three consecutive months.
10	<b>Quality Assurance</b> , when specified by purchase order, suppliers shall comply with the AS9100/ISO9001 quality system requirements or equivalent.
11	<b>Counterfeit/Suspected Unapproved parts</b> - The supplier agrees not to provide any product where the product cannot be traceable - Supplier is responsible for ensuring that all products are genuine in origin and agrees not to provide any product that is or could in the future be determined as counterfeit, unapproved or suspected unapproved product.
12	<b>Awareness</b> Suppliers employees are aware of their contribution to and importance of the following: <ul style="list-style-type: none"> <li>• Product or Service Conformity</li> <li>• Product Safety</li> <li>• Ethical Behavior</li> </ul>
13	<b>Test Reports:</b> Suppliers providing test reports (Chemical, Physical or other) have been authorized with having delegation authority over the content and validation of the test report data to the appropriate specifications.  Suppliers are responsible for the review and validation of any test reports as provided to Fuji Industries Corp.; Suppliers are assuring that the test reports meet the appropriate requirement for the product

	and process. Fuji Industries Corp. has the authority to re-validate the test reports at any time for any reason.
14	<b>Delivery:</b> Delivery shall be made as specified and strictly in accordance to the required delivery date on the PO, unless otherwise agreed upon by the seller and buyer.
